During SFY 2025, the state identified dental, durable medical equipment, and behavioral health services as an area of focus and has worked with plans to improve their policies and processes based on recent dental audit experiences. The State has continued to work with MCOs to improve oversight of institutional provider credit balances and credible allegations of fraud and increase prepayment reviews of providers as a tool for addressing persistent non-compliance.

The State recognized the need to provide the managed care health plans with encounter processing details, in addition to existing rejected encounter reporting, to aid in the validation of their encounter data. During the reporting period, the MMIS vendor began providing 835 response files to the health plans. As a result, the State and MMIS vendor are holding bi-weekly meetings with the health plans to address any identified encounter processing or submission issues.

An extended due date was requested by ABHWV and granted through November 22, 2024. ABHWV submitted their response to this request on December 5, 2024, six (6) business days beyond the extended deadline. The state department establishes timeliness standards "for all BMS Program Integrity and MFCU requests for data, records, or other information." This section requires that Mountain Health Trust service providers respond, "within fourteen (14) calendar days or within the timeframe designated in the request." Failure to comply with this provision of the agreement constitutes a program non-performance under standard number one as detailed in appendix F of the Mountain Health Trust Service Provider Agreement which addresses "failure to submit required reports, information requests, documentation, ad hoc reports, data certification forms, overpayment remittances, or any other item required within the timeframe provided by this contract." Program Non-Performance under this standard carries liquidated damages in the amount of "\$250 per business day per each item that is overdue until the satisfactory submission of the required report, documentation, ad hoc report, data certification form, or data required to meet any State or federal reporting requirements."

The Aetna Better Health of West Virginia (ABHWV) Special Investigations Unit (SIU) received an email from the Bureau for Medical Services (BMS/the agency) Office of Program Integrity (OPI) which requested the submission of fraud referrals for a list of four (4) provider cases. These referrals were required based on reviews of audit activity conducted by the ABHWV SIU which resulted in the identification of potentially fraudulent activity. ABHWV engaged directly with a provider for which a fraud referral was required and reached an agreement to resolve overpayments which potentially resulted from fraudulent activity. These actions taken by ABHWV constitute a failure to adhere to prohibitions and requirements related to program integrity and the recovery of overpayments which resulted in material harm to the ability of the OAG MFCU to investigate and prosecute the potentially fraudulent activity identified. Section 9.1.5 of the Mountain Health Trust (MHT) Service Provider Agreement states: "...If OPI accepts the case for State investigation, the MCO may not engage in investigation efforts other than coordination efforts with the State. The OPI must supply a notice to the MCO notifying it of the case acceptance status no later than the tenth (10th) business day after the MCO notifies the OPI of suspected fraud or abuse.
